BE SUSTAINABLE LIMITED - STATEMENT ON PAS 2060:2014 COMPLIANCE IN GLENDALE MANAGED SERVICES LTD's QUALIFYING EXPLANATORY STATEMENT 2024

NATURE AND SCOPE OF SUPPORT

Be Sustainable Limited was contracted by Glendale Managed Services Ltd to perform PAS 2060:2014 – Other Party Validation of its activities covering the financial year 2024, including a review of its Greenhouse Gas Footprint and its Qualifying Explanatory Statement (here after referred to as the Glendale QES 2024).

The scope of the support included: verification of utility, fuel, transport and subsequent GHG emissions reporting data and review and verification of the text and data in the Glendale QES 2024.

Our responsibility is to express an opinion on the text, data, chart and statements within the scope of the verification set out above with the intention to inform all Glendale's stakeholders.

The verification comprised desktop review, GOOGLE interview with the main Glendale contacts and review of source and combined GHG spreadsheets containing data from Glendale Managed Services Ltd.'s head office, operational depots and activities across the UK.

GHG FOOTPRINT VERIFIED

GHG emissions were verified to a limited level of assurance taking into account the requirements of the WRI/WBCSD GHG Protocol – A Corporate Accounting and Reporting Standard ('The WRI/WBCSD GHG Protocol') and the requirements of PAS 2060:2014. The verified GHG figures are outlined below:
